The following is the local educational agency's (LEA's) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Novato Charter School administrators met with staff, teachers, parents, students, and community members multiple times during the 2020-2021 school year to discuss learning issues associated with remote, hybrid and on-site instruction and how to best use funds from the Expanded Learning Opportunities Grant. We discussed these issues in a series of community meetings, during weekly faculty meetings, and in class parent meetings. In January and February, we conducted two surveys, one for parents only and one for the entire school community to gather feedback from parents, teachers, and staff on our plans to return to onsite learning and to mitigate learning loss associated with remote learning as a result of the pandemic.

In faculty meetings, we discussed the need for expanded learning opportunities and worked collaboratively to refine the educational supports we will offer as a school. The faculty also worked to develop a better understanding of essential standards and met with an SEL specialist to discuss best practices. This work helped us to refine our plan for the coming year.

We developed and wrote this Expanded Learning Opportunities plan in conjunction with our LCAP. We will continue to communicate with staff, faculty, students, and parents, to assess the effectiveness of this plan and to receive feedback on its implementation.

A description of how students will be identified and the needs of students will be assessed.

We will conduct benchmark Assessments for ELA and mathematics standards in grades one through eight. We will assess the reading levels of all students in grades two through eight using DIBELS. We will conduct interim and summative CAASPP assessments in grades three through eight. We began this series of assessments during the 2020-2021 school year and will continue to use them in the 2021-2022 school year to monitor student progress.

We use a Multi-Tiered System of Support along with a Student Study Team to identify students who have experienced learning loss. General education teachers will refer students to our Student Study Team who have specific learning or social and emotional needs. During the 2020-2021 school year, our school counselor met with grades six, seven, and eight to facilitate group circles on coping strategies, then followed up with individual students who were identified as having additional needs. A restorative practices facilitator met with a group of seventh and eighth graders to further discussion on challenging student issues.

Our general education teachers have received training to identify signs of students struggling with stress, isolation, and trauma. General education teachers also identify students based on attendance, engagement, and social and emotional learning needs.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

We will inform parents and guardians of the opportunities for supplemental instruction and support through a series of community meetings and parent meetings. We will post updates and announcements in our weekly school e-newsletter, on our school Facebook page, on our website, and in weekly email updates from class teachers to their parents. We will inform our community of expanded learning opportunities at our back-to-school night in September 2021. Class teachers and our student support team members will meet with individual families and students identified as needing extra support to further identify specific needs and explain our recommendations for special programs and supports in detail. We will provide Spanish translations on our website and to individual families as needed.

We will provide supplemental instruction after school and tiered support focusing on interventions and essential standards during school. We will also provide support for parents as needed.

Our plan includes:

- Addition of certificated and classified staff to support the MTSS process.
- Intensive reading, writing, and math intervention on campus through RTI supplemental curriculum, and software.

- Purchase of ELA curriculum, math materials, science textbooks and materials
- Purchase ELA and Math assessment systems, benchmark assessments and screenings to determine learning loss.
- Expanded counseling and mental health services.
- Purchase classroom materials for social and emotional learning.
- Individual support for families to overcome obstacles preventing students from returning to on-site instruction.
- Student services department outreach to all students and families in need.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

We have not received any Elementary and Secondary School Emergency Relief Funds. We have developed a long-term plan to incorporate Expanded Learning Opportunities (ELO) funds so that programs begun in the 2020-2021 or 2021-2022 school year can be maintained in following school years. ELO funding will be used to identify students in need, mitigate learning loss, and improve the social emotional and physical well-being of students. The different funds available from our ELO grant and other sources of funding will be divided up and used according to the regulations for each.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
